### TAX HELP

AARP Foundation Tax-Aide is a national program offered locally in cooperation with the IRS, the N.C. Dept. of Revenue, the Buncombe County Library System, and the Council on Aging of Buncombe County. It offers FREE tax preparation for taxpayers with low- and moderate-incomes, with special attention to those age 60 and older. This service will be available from Wednesday, February 1, 2012 through Tuesday, April 17, 2012. Both Federal and North Carolina State individual tax returns will be electronically filed for safe and accurate preparation and faster refunds. (Note: Bring a voided check so the preparer can obtain bank information for direct deposit of any refund.)

### MEET OUR NEW NEWSLETTER EDITOR

Mike Grillot was born in Ann Arbor, Michigan and attended the University of Detroit and Northwestern University. In 1978, after a brief academic teaching career at the University of Kansas and Centre College, and a short stop at the Federal Reserve Bank of Kansas City, he began an almost 32 year career as an Economist at the U.S. Department of Energy's headquarters in Washington, DC with the Energy Information Administration (EIA). At EIA, Mike worked primarily in the international area including: following developments in the world oil market, forecasting world oil prices, and projecting world energy demand. His last 15 years were spent overseeing the development of EIA's fuel-specific world energy demand and supply data for most countries of the world.
